



## **Royal Sutton Coldfield, Lichfield & Tamworth and Cannock Chase Awards 2025**

Not sure which award to apply for? Please see below for a breakdown of each category.

SLTC Awards are free to enter and open to all businesses regardless of whether they are a member of the Greater Birmingham Chambers of Commerce. Your organisation must either be a member of one of the following Chambers, or based within, Royal Sutton Coldfield, Lichfield, Tamworth or Cannock Chase.

### **Small Business of the Year**

This category is open to any small or micro business that has up to 30 employees. Applicants must be able to demonstrate excellent and outstanding achievement in all aspects of their organisation including strong growth, innovation and leadership as well as a clear vision. To qualify for entry, organisations must be based in the following postcodes:

- To qualify for entry in the Royal Sutton Coldfield Chamber Small Business of the Year award, your organisation must be a Royal Sutton Coldfield Chamber member or based in a postcode beginning with B72, B73, B74, B75, B76.
- To qualify for entry in the Lichfield Chamber Small Business of the Year award, your organisation must be a Lichfield Chamber member or be based in a postcode beginning with WS7, WS13, WS14.
- To qualify for entry in the Tamworth Chamber Small Business of the Year award, your organisation must be a Tamworth Chamber member or be based in a postcode beginning with B77, B78, B79.
- To qualify for entry in the Cannock Chase Chamber Small Business of the Year award, your organisation must be a Cannock Chase Chamber member or be based in a postcode beginning with WS6, WS11, WS12, WS15, WV5, WV8, WV9,

### **SLTC Large Business of the Year**

This category is open to any business that has over 30 employees. Applicants must be able to demonstrate excellent and outstanding achievement in all aspects of their organisation including strong growth, innovation and leadership as well as a clear vision.

### **SLTC Entrepreneur of the Year**

This award is open to entrepreneurs running micro businesses (under 10 employees) who are changing their industries, the economy and society in unique, original and positive ways. Individuals who can demonstrate entrepreneurial achievement amongst people and companies that exhibit vision, leadership and success.

### **SLTC Community Impact Award**

This award is open to organisations who are contributing a positive impact on their local community through collaborations and partnerships with charities and education and can demonstrate CSR activity and charity initiatives.

### **SLTC Young Professional of the Year (18-35 years of age)**

This category is open to individuals aged 18-35 years and will recognise the contribution made by young achievers who are dynamic and dedicated to what they do and have made an outstanding contribution to their business.
